IN FOCUS: CLAIMS SUPPORT

An understanding of a motorcyclist's vulnerability on the road by the Torque Bike team played a key part in this claims success story

Our in-house Claims Handler therefore encouraged our client to find a witness

They reported that one of their employees had been forced to ride defensively on one of the business' scooters to avoid a collision with a third-party car, which exited suddenly from a business park and moved into the path of the scooter.

However, because no contact was made,

The defensive action taken by the employee resulted in them falling

the car driver's insurer claimed no liability for the incident and

who could make a statement about how collision had been imminent. A witness was then found by the employee on Facebook, who agreed to make a statement and testify in court. The third party's insurer continued to present barriers, but our Claims Handler determinedly chipped away at the case, chasing the other insurers until the case went to court.

At the hearing, the judge ruled in favour of Shrewsbury Honda Centre and ordered the car driver's insurers to pay for the damage. Thanks to our team's recognition of a motorcyclist's

vulnerability and the need for defensive riding, this case therefore reached a successful resolution.

TYPICAL COVERS FOR YOUR BUSINESS

At Torque Bike, our aim is to ensure your business has the right level of protection, bespoke to your individual needs. Below is a selection of the covers available to consider when tailoring your policy.

Employers' Liability Insurance:

This is a legal obligation if you employ anyone within your business. It provides protection should an employee claim they were injured or the employment caused an illness during the time they worked for you. It also covers temporary staff and volunteers if working under your direct supervision and control.

Public Liability Insurance:

This protects you if a customer or member of the public claims they were injured, or their property was damaged because of your activities.

Road Risk Cover:

If you need to test ride a motorcycle you don't own, or transport it to another location, this will protect you for the journey. It can be extended to include accompanied and unaccompanied demo cover.

Material Damage Insurance:

This protects your business assets against a variety of losses, such as fire, theft and flood. You can also include your buildings, vehicles, tools and other business equipment should they suffer damage or be stolen.

Self-Drive Hire Cover:

If you rent out your motorcycles, this will provide financial protection should a motorcycle from your fleet be lost or damaged. It includes third-party liability.

Transit Cover:

Protection for motorcycles or parts stolen or damaged in transit (up to four motorcycles as standard).

Products Liability Insurance:

Cover for injury or damage caused to third parties arising from faulty products and services your business provides.

Motor Trade Risks:

Protection while vehicles are being driven on public roads for business purposes. This can cover multiple locations and employees, and you will have the option to choose comprehensive, third-party only, or third-party, fire and theft cover.

Riding Training Cover:

This covers you for providing learner courses.

Wide Unaccompanied Demo Cover:

Test ride protection for customers.
